



AGRINET® NEWS AFFILIATION AGREEMENT
INTERNET Delivery

This agreement made this ____ day of _____, _____ between Ray Communications, Inc. (hereafter referred to as "NETWORK") and _____ which owns and operates station _____ located at _____ (hereafter referred to as "STATION").

The parties agree to the following during the term of this affiliation agreement and any renewal thereof:

I. NETWORK PROGRAM SERVICE

- A. Network agrees to provide and Station agrees to carry AGRINET® programming as specified in EXHIBIT A. The Station to air program(s) on the station detailed in EXHIBIT B.
- B. Station agrees to carry programs in their entirety including network commercial announcements.
- C. Network will provide broadcast programming to Station via Internet at <http://www.agrinetradio.com>. Internet audio files will be available for downloading each weekday as indicated in EXHIBIT B.
- D. Station will submit in writing to Network each month, an affidavit as proof of broadcast clearance. Affidavits should be submitted to Network by the tenth (10th) of each month following broadcast via e-mail with a signed and notarized copy by mail.

II. GENERAL

- A. Neither Station nor Network shall incur any liability hereunder because of Network's failure to deliver, or Station's failure to broadcast Network programs due to:
 - 1. Failure of facilities;
 - 2. Labor disputes;
 - 3. Government regulation or court action, and/or;
 - 4. Causes beyond the control of the party so failing to broadcast or deliver.
- B. With respect to Network programs offered pursuant to this Agreement, nothing herein contained shall be construed to prevent or hinder Station from rejecting or refusing Network programs which Station reasonably believes to be unsatisfactory, unsuitable, or contrary to public interest, and/or; Substituting a program, which in the Station's opinion, is of greater local or national importance. The station will give Network prompt notification of any such refusal, rejection or substitution with 90 days before program termination.
- C. Station may assign or transfer any rights or privileges granted to it under this Agreement without Network's prior written consent.

D. Station agrees not to authorize, cause, permit, or enable anything to be done whereby any program which network supplies to Station may be used for the purpose other than broadcasting by station in the community in which it is licensed, which broadcast is intended for reception by the general public.

III. TERM AND TERMINATION

A. The term of this agreement shall be from the ____ day of _____, _____ to the ____ day of _____, _____.

B. This Agreement shall be automatically renewed for additional consecutive periods of two (2) years unless and until either party shall give the other party written notice of election not to renew on less than ninety (90) days prior to the expiration of the current contract period. During the term, including the renewal period, either party shall have the right to terminate this Agreement effective at any time by providing three (3) months advance written notice to the other party.
